## PONTOON RENTAL POLICY

### GENERAL GUIDELINES:

Pontoon is located at Upper Lake Nemahbin and is to only be used on Upper Nemahbin - Due to varying water levels, going to Lower Nemahbin or Lower Nashota is prohibited.

Rental times are 4 hours or 8 hours (specific time slots for weekends & holidays only)

#### **Weekend(Sat & Sun) & Holiday Rental Times**

4 Hour weekend times slots are from 9am to 1pm, 2pm to 6pm, 3pm to 7pm, or 4pm to 8pm

8 Hour weekend times slots are from 9am to 5pm, 10am to 6pm, 11am to 7pm, or Noon to 8pm

#### **Weekday Rental Times**

Pontoon Rentals will be open for any 4 or 8 hour rentals as available without specific start times

\*\* Renters should arrive at least 15 minutes prior to rental period or call if running behind. Arriving 20 minutes or more after rental period results in a no call/no show and we cannot guarantee the pontoon will still be available... see cancellation policy below\*\*

#### **NO WAKE - Holidays & Sundays 12p-3p**



**Initials weekend/holiday rentals only**

Number of passengers/weight limits will be strictly enforced to assure a safe voyage (determined by which pontoon you will be renting)

#### **Pets are NOT allowed on pontoons**

Renters must be 25 years of age or older with a valid driver's license, valid credit card, and boater's safety card (if born after 12/31/1989). No one under the age of 18 is permitted to operate the pontoon

Renter is required to fill out and sign a waiver/hold harmless acknowledging they will be responsible for all risk associated with renting the watercraft. The renter on file is to be the only passenger to operate the pontoon

**All pontoon rentals will require a \$100 rental deposit to confirm reservation. Holidays will require full payment to confirm reservation.**

We will provide a tutorial on proper pontoon usage prior to your day of fun, as well as life jackets for all passengers, fuel for the pontoons that is built into the price, and a cooler with ice if requested

**Federal law requires children under the age of 13 to wear a USCG-approved life jacket while underway in an open vessel on federally controlled waters**

**Late Return:** Renter will be billed at \$25 per 15 minutes after rental period is scheduled to end

**Cleaning Fee:** If extensive cleaning is required, renter will be charged a \$50 cleaning charge

## **Cancellation Policy:**

**Cancellations must be made 14 days prior to rental period to recover rental deposit, minus \$15 service fee**

Rentals cancelled less than 14 days prior will lose 50% of the rental deposit

No call/No show on rental will forfeit entire deposit – **NO CALL/NO SHOW will be assumed if renter is not present 20 minutes after rental period begins and will be freed for other renters**

### **WEATHER POLICY:**

Nomad Boardsports is not responsible for the weather. Please be sure to check the weather in advance of putting your deposit down. We will **NOT** refund your deposit due to weather, but we will be happy to put it towards your rescheduled pontoon rental.

Cancellation policy as stated in the previous section, applies to weather cancellations without rescheduling, with the exception of severe weather conditions.

Severe weather conditions exceptions include: Tornado, Tornado Warning/Watch, Thunderstorm, Thunderstorm Watch/Warning, Flash Flood, Flash Flood Watch/Warning, Hail, Extreme Winds, and Lightning.

## **Damage Policy:**

**The renter is responsible for all damages and losses to the pontoon**

Nomad Boardsports will provide a pre-trip and post-trip walk through of the pontoon. In the case that the post-trip checklist identifies damages not noted pre-trip, we will provide an itemized repair bill, including lost time(if necessary) that begins when the rental is returned by the renter after the rental period, and when it is once again available for rental.

The bill must be paid in full at the time it is presented to the renter

## **Unsafe Use:**

If it is determined that the renter has engaged in hazardous or unsafe use of the pontoon, Nomad Boardsports can immediately terminate the rental agreement and the renter is required to return the vessel to the docking area at that moment.

The renter will not be refunded any portion of payment or deposit made

Nomad Boardsports will determine if there is “hazardous or unsafe” use at their own discretion

## Alcohol and Drugs:

Wisconsin law prohibits anyone from operating a motorboat or manipulating water skis or similar devices while under the influence of alcohol or drugs. Alcohol and drugs cause impaired balance, blurred vision, poor coordination, impaired judgment, and slower reaction times.

- Anyone who operates or attempts to operate a vessel is deemed to have given consent to an alcohol and/or drug test.
- It is illegal for a person to operate a motorboat or use water skis, a surfboard, or other device if he or she:
  - Is under the influence of an intoxicant or a controlled substance or...
  - Has a blood alcohol concentration of 0.08% or greater
